The appeal was not frivolous as was the instant motion for sanctions. The Board, however, has failed to meet its burden of proving by clear and convincing evidence that the appeal is frivolous. 12 The Board has offered no explanation of the lack of any mailing whatsoever to Shedd's attorneys of the Board's decision and order. The failure of the Board to provide a copy of the decision and order to Shedd's attorneys is a violation of this court's order dated November 4, 1987, requiring the Board to provide Shedd's counsel with a copy of
